Dave was honored for his many years of contributions to the Audubon mission, including his work to make renewable energy safer for birds, establish Marine Protected Areas in Southern California, and support marine bird conservation through his work with International Bird Rescue. In addition to:

### SFVAS SUPPORTS SANTA SUSANA FIELD LABORATORY CLEAN-UP TO OPEN SPACE STANDARD CONSISTENT WITH THE BOEING COMPANY'S CONSERVATION EASEMENT

For more than seven years, SFVAS has been heavily involved in advocating for a proper clean-up of the Santa Susana Field Laboratory that is fully protective of the natural, cultural, and historical resources present on the site, as well as public health both on the site and in surrounding communities. To further these ends, the SFVAS Board of Directors unanimously passed the Resolutions copied below. The Resolutions are self-explanatory.

RESOLUTION TO SUPPORT REMEDIATION OF SANTA SUSANA FIELD LABORATORY TO OPEN SPACE STANDARD

WHEREAS, based on information available at the time, in March, 2015 the San Fernando Audubon Society Board of Directors (the Board) unanimously passed a Resolution supporting remediation of the Santa Susana Field Laboratory (SSFL) a to risk-based suburban residential standard (text of resolution attached below); and

WHEREAS The Boeing Company (Boeing) owns approximately 2,400 acres of the 2,850 acre site; and

WHEREAS, at the time the resolution was promulgated, the Board was aware that Boeing had previously pledged publicly on numerous occasions to preserve their property at SSFL as open space; and

WHEREAS Boeing recently entered into an agreement with the North American Land Trust (the Trust) to have the Trust administer and enforce a Conservation Easement (the Easement) governing future uses of the Boeing-owned portions of the site as open space; and WHEREAS the Easement is a legally enforceable document; and • Representing Audubon on the Marine Life Protection Act process that identified Protected Areas in Southern California oceans

• Representing SFVAS on LA County Significant Ecological Areas program of the Los Angeles County General Plan

- Representing SFVAS on renewable energy in the Antelope
- Valley and conservation of Swainson's Hawk habitat • Representing SFVAS on Desert Renewable Energy Conservation Plan for 22 million acres of California's Mojave and Colorado Desert which resulted in Phase I putting 10 million acres of desert into higher conservation designations while identifying over 300,000 acres that would be suitable for utility-scale renewable energy development.
- Representing SFVAS at Holiday Lake
- Acting as Southern California's "Climate Activist" leading Southern California chapters
- And for always responding "what can I do" to any conservation or chapter challenge
- Audubon couldn't have found a better advocate for birds in

California.

William Dutcher was a prominent amateur ornithologist of the late 19th and early 20th centuries and in 1905 was appointed the first President of the National Audubon Society. The Dutcher Award was created in his honor to recognize superior volunteer service by Audubon leaders that results in bird conservation at scale.

WHEREAS the Easement assures that future use of the property will be limited to that of open space intended to conserve natural, historical, and cultural resources; and

WHEREAS the Easement prohibits commercial, residential, and agricultural use of the site in perpetuity; therefore, it is

RESOLVED that the San Fernando Valley Audubon Society hereby supports remediation of the SSFL to an open space standard consistent with future use of the site; and it is further hereby

RESOLVED that the previous resolution supporting remediation of SSFL to the suburban residential standard is hereby updated and superseded.

PASSED UNANIMOUSLY BY SAN FERNANDO VALLEY AUDUBON SOCIETY BOARD OF DIRECTORS ON JUNE 26, 2017.

#### ATTACHMENT

AD HOC SHORT TITLE (by Mark Osokow): Resolution supporting a clean-up of Santa Susana Field Laboratory to risk-based suburban residential standard.

"SFVAS supports remediation of contamination at SSFL only to the standard for suburban residential areas. SFVAS opposes the unprecedented proposal to require remediation to background level, which would devastate outstanding wildlife habitat, extremely significant historical structures from the USA Space Age, and create significant health and safety impacts on communities near routes that trucks hauling soils offsite would pass. Background remediation would destroy Native American cultural sites, which remediation to the suburban residential standard would not."

# Reaching Out Through Education by Paula Orlovich

The Sepulveda Basin Environmental Education Program (SBEEP) is anticipating another exciting year, as we prepare to welcome students from the Los Angeles Unified School District for fun and informative curriculum-based field trips.

# Phainopepla Photo of the Month by Jackie Wollner

### Black Oystercatcher (Haematopus bachmani)

This month's striking photo of a Black Oystercatcher was contributed by SFVAS chapter member and social media chair, Jackie Wollner. The scientific name is Haematopus bachmani. Haematopus is from the Latin for "blood-red foot" and the species name, bachmani, was bestowed by John James Audubon himself, in honor of his friend, the Reverend John Bachman. Jackie took this shot of a bird while it was foraging for mussels at low tide. She writes: "He or she was in the company of a mate. Luckily for me this individual looked up to regard me just long enough for me to get a shot of those amazing eyes. Black Oystercatchers are one of my favorite birds to photograph. Their eyes

are like egg yolks. Their bills are unbelievably bright red-orange. They have so much vibrant color around their face, yet they have delicate pale pink legs that remind me of the ballet tights I wore as a child."

# July and August Field Trip Reports by Richard Barth

We visited Mt. Pinos on July 15, birding at 8300 ft and above. Our little group of participants managed to find many of the special birds here. Green-tailed Towhee, White-headed Woodpecker, Hairy Woodpecker, Cassin's Finch, Purple Finch, Mountain Quail, Brown Creeper and Pygmy Nuthatch were tallied. A briefly-seen bird was believed from it's song to be a "Thick-billed" Fox Sparrow. We were surprised to come upon a Black-throated Gray Warbler, the first one found on this trip in memory. Other species of interest included Steller's Jay (on the drive up), Mountain Chickadee, Chipping Sparrow, Western Wood-Pewee (heard), White-breasted Nuthatch, Northern Flicker (heard), Violet-green Swallow, Yellow-rumped Warbler and American Robin. Western Bluebird and Oregon Junco are common on the mountain. Two coveted species missed on the trip were Clark's Nutcracker and Dusky Flycatcher.

On August 19 we birded the Chilao, Buckhorn and Charlton Flat areas along the Angeles Crest. We couldn't have asked for a more pleasant morning of birding. Expected favorites like Hairy Woodpecker, White-headed Woodpecker, Green-tailed Towhee and "Thick-billed" Fox Sparrow did not disappoint, and we picked up Rock Wren and Lawrence's Goldfinch which are unusual finds on this trip. A Bell's Sparrow, apparently having wandered upslope from the Antelope Valley post breeding, showed up at the Chilao Visitor Center feeders. The flycatchers found were Western Wood-Pewee and Pacific-slope; our warblers were Nashville (a nice find) and Wilson's. A Wrentit gave us one brief look. Additional species of note on the day were Warbling Vireo, Black-headed Grosbeak, Oak Titmouse, Band-tailed Pigeon and House Wren. Mountain Chickadee was the most abundant species this time and we also tallied good numbers of Steller's Jays, Pygmy Nuthatches, White-breasted Nuthatches, Western Bluebirds and Dark-eyed Juncos. We missed Cassin's Finch, Purple Finch and Dusky Flycatcher.

# Conservation Corner by Dave Weeshoff

The Migratory Bird Treaty Act (MBTA) is America's cornerstone bird conservation law. Our National Audubon led the charge to help pass the law in 1918, and it has since saved millions of birds and numerous species from the brink of extinction. Now signs are pointing to growing threats to this law, placing America's birdlife in danger.

The MBTA protects most of the nation's native birds by making it unlawful to kill, hunt, sell, or possess more than 1,000 species, along with their nests, eggs, and feathers, without a permit. It is credited with helping turn the tide against the plume trade and market hunting, which devastated bird populations in the early 20th century. Today, threats to birds continue (including Climate Change), and the protections afforded by the MBTA are even more vital as ever.

In recent years, the law has come under attack. Audubon rallied to oppose the "bird killer amendment" in 2015, which would have prevented any enforcement of the law. Legislation introduced last Congress would have given a free pass to deaths from industrial activities that incidentally kill birds, such as oil waste pits, power lines, and gas flares. Neither effort moved forward in the last Congress.

Audubon also supported a proactive approach to strengthening the MBTA by addressing these industrial activities more directly through a permit process. The process has since been suspended by the Trump administration.

In this current political environment, core laws like the Endangered Species Act and others are under increasing attack. Chatter about undermining the MBTA is growing, from the halls of Washington to the pages of the Wall Street, and the threat to the law is expanding. These efforts could limit or end the protections for about 1,000 species of birds, from backyard birds like American Robins, to Red-tailed Hawks, and Common Loons, and declining species across the country like American Kestrels, Cerulean Warblers, and more.

As we approach the law's one-hundredth anniversary, SFVAS will be on guard to continue Audubon's proud legacy and keep the MBTA just as vital and effective in its next century.
